## PROSPECTUS FOR ADMISSION INTO BACHELOR OF SCIENCE (B.Sc) IN ALLIED HEALTH SCIENCES COURSES INCLUDING BPT AND B.Sc (MLT) COURSES FOR THE ACADEMIC YEAR 2023- 24

### 1. REGULATIONS

A) These Regulations are applicable for admission into Competent Authority Quota Seats in Government and Private B.Sc. (Allied Health Sciences) colleges including BPT and B.Sc (MLT) course. The following new courses are sanctioned by State Government from 2023-24 (As per G.O.MS.No. 14 HM & FW Department (C1), dated 11.02.2023).

1. *B.Sc Anesthesia Technology*
2. *B.Sc Operation Theatre Technology*
3. *B.Sc Cardiac and Cardio Vascular Technology*
4. *B.Sc Renal Dialysis Technology*
5. *B.Sc Optometry.*
6. *B.Sc Respiratory Therapy Technology*
7. *B.Sc Neuro Science Technology.*
8. *B.Sc Critical care Technology*
9. *B.Sc Radiology and Imaging Technology.*
10. *B.Sc Audiology and Speech Therapy Technology.*
11. *B.Sc Medical Records Sciences*
12. *B.Sc Nuclear Medicine* ( No Institution has been granted NOC by Government till date)
13. *B.Sc Radio Therapy Technology* ( No Institution has been granted NOC by Government till date)

Note: If any new college/Institution is permitted for above courses, the same will be considered for admissions. No fresh registrations shall be done or notifications will be issued.

B) All the Candidates shall fulfill the regulations for admission into B.Sc.(Allied Health Sciences) Degree Courses including BPT and B.Sc (MLT) course for admission into Competent Authority Quota Seats.

The candidates are advised to take a print out of the Prospectus / instructions to fill the application form from the website [www.knruhs.telangana.gov.in](http://www.knruhs.telangana.gov.in) before proceeding to fill the online application form.

- C). The list of colleges and seat matrix for Competent Authority Quota seats into B.Sc(Allied Health Sciences) Courses including B.Sc (MLT) course at Government and Private Colleges for academic year 2023-24 will be displayed in the KNRUHS website before exercising web options for counseling.
- D). Tuition Fee will be as notified by the State Government.
- E). In case any new courses/new institutions are permitted by State Government/University for the Academic Year 2023-24, those seats will also be filled up. NO FURTHER NOTIFICATIONS WILL BE ISSUED.

## 2. ELIGIBILITY:

i. The candidates should be citizens of India and should satisfy the local or non-local status in Telangana /Andhra Pradesh as laid down in Telangana Educational Institutions (Regulations of admissions) order, 1974 and the selection will be done as per the procedure laid down in the G.O.P.No.646, dated 10-07-1979 as amended in G.O.Ms.No.42, Higher Education (EC2), dated 18-05-2009 and the Government Orders on Rules of Admissions into Allied Health Sciences courses.

ii. The candidates have to apply online and upload the original certificates in response to notification issued by KNRUHS. The merit rank notified after verification of certificates by KNR University of Health Sciences, shall be the basis for selection into B.Sc.,(Allied Health Sciences) courses including BPT and B.Sc (MLT) courses into Competent Authority Quota seats.

iii. EDUCATIONAL QUALIFICATIONS: For B.Sc Allied Sciences courses including BPT and B.Sc (MLT) course

Candidates seeking admission should have passed 2 years Intermediate Examination (10 + 2 pattern) with Botany, Zoology, Physics, Chemistry and English conducted by Board of Intermediate Education, Telangana state.

or

Any other examination of (10 + 2 pattern) from recognized Board under AISSCE / CBSE/ ICSE / SSCE / HSCE / NIOS / TOSS of other equivalent Board with Biology, Physics and Chemistry recognized as equivalent by Board of Intermediate Education, Telangana state.

Or

Intermediate (10+2) with Bridge course with Biology and Physical Science.

Note: Candidates possessing qualification of the University / Board or an institution outside the state should produce a certificate of equivalence from the Board of Intermediate Education of Telangana, Hyderabad to the effect that the qualification possessed is equivalent to or higher than Intermediate examination with the above mentioned subjects conducted by the Board of Intermediate Education of Telangana of BPC group.

- iv. AGE: Candidates should have completed the age of 17 years as on 31st December 2023.  
Note:

- a) Age shall be calculated on the basis of date of birth as indicated in the Secondary School Certificate examination or equivalent examination.
- b) No request for relaxation of age of a candidate shall be permitted.
- c) Candidates born on or after 02-01-2007 are not eligible

- v. DURATION OF THE COURSE – 4 years including 1 year compulsory Internship.

- vi. Duration of the course for BPT course – 4 years + 6 months compulsory Internship

### 3. ONLINE APPLICATIONS

The on-line application form for determining merit position for Competent Authority Quota seats will be available on the website <https://alliedhs.tsche.in> from **8.00 AM on 27-10-2023 upto 06.00 PM. on 02-11-2023.**

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://www.knruhs.telangana.gov.in/> or from <https://alliedhs.tsche.in> before proceeding to fill the application form.

The candidate should fill the online application form available in the Website with the data required for through computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the

payment of application fee through Online.

#### Registration and Verification Fee:

- a) The Registration and Verification fee Rs. 2500/- (Bank transaction charges extra) for OC & BC candidates and Rs. 2000/- (Bank transaction charges extra) for SC/ST candidates shall be paid online through payment gateway i.e., Debit card / Credit card or Net Banking.\*\*
- b) *\*\*Registration and Verification fee once paid will not be refunded or adjusted to a further date.*

The candidates are advised to download and read the Prospectus of the course to verify for eligibility under local/non local category.

#### 4. RESERVATION OF SEATS:

##### 4.1. Reservation of seats for Scheduled Castes & Scheduled Tribes.

1. Out of the total seats under Competent Authority Quota 15% are reserved for SC category candidates and 10 % are reserved for ST category candidates. If any seat reserved for the Scheduled Tribes is not filled up they will be open to the candidates belonging to Scheduled Castes and Vice-Versa.
2. If the candidates from Scheduled Castes & Scheduled Tribes are not available these reserved seats shall be converted to open category seats and allotted on the basis of merit.
3. Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified in the list as per the Telangana State Government orders will be considered against the reserved seats.

##### 4.2. Reservation for BC Candidates:

- a) 29% of the total seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes and shall be allotted among the five sub groups of Back Ward Classes as follows:-

BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.

- b) Candidates who belong to the notified Backward Class castes of the States of Telangana which are listed in the Telangana State Government

orders shall be considered for reservations.

i. If eligible candidates belonging to Backward Classes of a particular sub-group are not available, the left over seats can be allotted to the candidates of next sub- group ie., BC A to BC B to BC C to BC D to BC E.

ii. If eligible candidates of Backward Classes category are not available for the 29% seats reserved for them, the left over seats shall be converted to open category seats and shall be allotted as open category seats on the basis of merit.

c) While calculating the number of seats in the sub-groups if the total number of seats falls short of or exceeds 29% it shall be limited to 29% by adding or eliminating the candidates on the basis of merit in the sub-groups in which the fractions were rounded to nearest figure.

4.3. EWS Reservations :10% of total seats under Competent Authority Quota are reserved for EWS category candidates.

EWS candidates shall submit EWS eligibility certificate valid for the year 2023- 24 issued by Competent Authority

4.4. Permanent Caste Certificate:

a) Scheduled Caste, Scheduled Tribe and Backward Class candidates shall in support of their claim, have to furnish Permanent caste certificate issued by the Competent Authority of Government of Telangana/AP.

b) The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized as per the rules notified by the concerned department officials of Government of Telangana.

c) The decision of the verification officer deputed by the Director / Commissioner of BC Welfare, SC Welfare and ST Welfare from the Government of Telangana is final in all respects.

d) Candidates from the Scheduled Castes, Scheduled Tribes and Backward

Classes belonging to Telangana State for castes which are notified as per the Telangana Government orders will be considered against the reserved seats.

**4.5. RESERVATION FOR WOMEN CANDIDATES:**

33 1/3% of seats are guaranteed for women candidates in each category i.e., Open category, EWS, Scheduled Castes, Scheduled Tribe, Backward Classes Group A, B, C, D and E. This regulation of guarantee shall not be applicable if women candidates selected on merit in each category form 33 1/3% or more of the seats therein. When the number of women candidates falls short of this percentage, it would be made up by replacing the last selected male candidates by women candidates in that category.

**4.6. RESERVATION UNDER PERSONS WITH DISABILITIES (PWD) CATEGORY:**

5% of total seats in each course and category shall be reserved for the Persons with Disabilities (PWD) i.e., OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E categories as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board constituted by the University, comprising of Professors from Government Medical Colleges from relevant specialties. The decision of the Medical Board constituted by the University with regard to percentage of Disability is final.

**4.7. RESERVATION FOR LOCAL CANDIDATES:**

4.7.1. 85% of the seats in each local area will be reserved for local candidates, remaining 15% un-reserved seats will be filled by applicants as defined below.

4.7.2. Definition of Local Area

a) The part of the state comprising the districts of Adilabad, Hyderabad, (including twin cities), Ranga Reddy, Khammam, Karimnagar, Medak, Mahabubnagar, Nalgonda, Nizamabad and Warangal shall be regarded as the Osmania University Area or Local area for Telangana.

b) The part of the State comprising the districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam



shall be regarded as Andhra University Area.

- c) The part of the State comprising the districts of Anantapur, Kurnool, Chittoor, Cuddapah and Nellore shall be regarded as Sri Venkateswara University Area.

#### 4.8. Definition of Local Candidates

4.8.1 A candidate for admission shall be regarded as a local candidate in relation to a local area.

- a) If he/she has studied in educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared in the Relevant Qualifying Examination.

- b) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for Intermediate Examination, he/she has not studied in any educational institution, if has resided in the local area for a period of not less than four years immediately preceding the date of commencement of relevant examination in which he/she appeared, or as the case may be, first appeared then he/she becomes a local candidate.

4.8.2 A candidate for admission to the course who is not regarded as a local candidate under sub regulation 4.8.1 above in relation to any local area shall.

4.8.2.1 If he/she has studied in educational Institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for the relevant qualifying examination be regarded as a local candidate in relation to

- i) such local area where he/she has studied for the maximum period out of said period of seven years,
- ii) where the periods of his/her study in two or more local areas are equal, such local area where he/she has studied last in such equal periods

4.8.2.2 If, during the whole or any part of seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she not studied in the educational institutions in any local area, but has resided in the State during the

whole of the said period of seven years, be regarded as local candidate in relation to:

- i) such local area where he/she has resided for the maximum period out of the said period of seven years,
- ii) Where the periods of his/her residence in two or more local areas are equal such local area where he/she has resided last in such equal periods.

Explanation – For purpose of this Sub regulation.

- a) “Educational Institution” means a college, a school imparting education upto and inclusive of tenth class, or other institutions by whatever name called whether managed by Government, Private body, local authority or University and carrying on the activity of imparting education there in whether technical or otherwise and includes a Polytechnic, Industrial Training Institute and a Teachers Training Institute but does not include a Tutorial Institution.
- b) Relevant qualifying examination for admission to B.Sc. Allied Health Sciences courses of study means a pass in the examination, which is the minimum educational qualification for admission to such course of study.

Note: The relevant qualifying examination for admission to B.Sc(Allied Health Sciences) courses including B.Sc (MLT) being Intermediate with Bi.P.C. or its equivalent examination, the question whether candidate is a local candidate will be determined with reference to the first appearance in the Intermediate examination or equivalent examination even in the case of an applicant possessing B.Sc. or M.Sc. Degree.

- c) a) In reckoning the consecutive academic years during which a candidate has studied, any period of interruption of his/her study by reason of his/her failure to pass any examination ,and;
  - b) Any period of his/her study in a State-wide University or Statewide educational institution shall be disregarded
- d) The question whether any candidate for admission to any course of Study has resided in any local area shall be determined with reference to the places where the

candidate actually resided and not with reference to the residence of his/her parent or guardian

4.8.3 While determining the number of seats to be reserved in favour of local candidates under regulation 4.8.1 any fraction of a seat shall be counted as one provided there shall be one Unreserved Seat.

**4.8.4** If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled in as if it has not been reserved.

**4.8.5** Applicants who claim to be local candidates with reference to regulation 4.8.1

4.8.6 (a) shall produce evidence in the form of study certificate/certificates issued by the Heads of Educational Institution/Institutions concerned, indicating the details of the year or years in which the candidate has studied in educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic years in which he/she appeared or as the case may be, first appeared for the Intermediate examination or its equivalent. Those who do not qualify as local candidates under sub regulation 4.8.1 a) but claim to qualify by virtue of residence under regulation 4.8.1 (b) Shall produce a certificate issued by an officer of the Revenue Department not below the rank of a Mandal Revenue Officer in the form annexed in G.O.Ms.No.628 Education, dated the 25th July, 1974, (appended to the application).

4.8.6.1 Applicants who claim to be local Candidates under 4.8.1 (a) shall produce evidence in the form of study certificate issued by the heads of the Educational Institution / Institutions concerned indicating the details of the year or years in which the candidate has studied in the respective educational Institutions for a period of not less than seven consecutive academic years ending with the academic year in which he / she appeared, or as the case may be first appeared for the Intermediate Examination or its equivalent. Those who do not qualify as local candidate under the regulation 4.8.1 (a) but claim to qualify by virtue of residence under regulation 4.8.1 (b) shall produce a certificate of residence issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer in the form similar to that Annexed to G.O.Ms.No.628, Education, dated 25<sup>th</sup> July 1974 with necessary modifications (appended to the application).

4.8.7 The following categories of candidates are eligible to apply for admission to the 15% of unreserved seats.

- a) All Candidates defined under regulation 4.8.1 & 4.8.2
- b) Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State or whose parents have resided in the State for a period of ten years excluding periods of employment outside the State. (Certificate to the effect from Revenue Official not below the rank of Mandal Revenue Officer from where the candidate is claiming eligibility should be enclosed.)
- c) Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi public Institutions within the State. (Certificate from the Head of the Institution / Department should be enclosed)
- d) Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government, a University or other competent authority and similar other quasi Government Institutions within the State. (Certificate from the Head of the Institution/ Department should be enclosed)

4.9 In colleges established after 02-06-2014 (after formation of Telangana State), all the seats under Competent Authority Quota are reserved for local candidates (vide Lr.No. 8545/C1/2023 from HM&FW Dept., dated 30-09-2023).

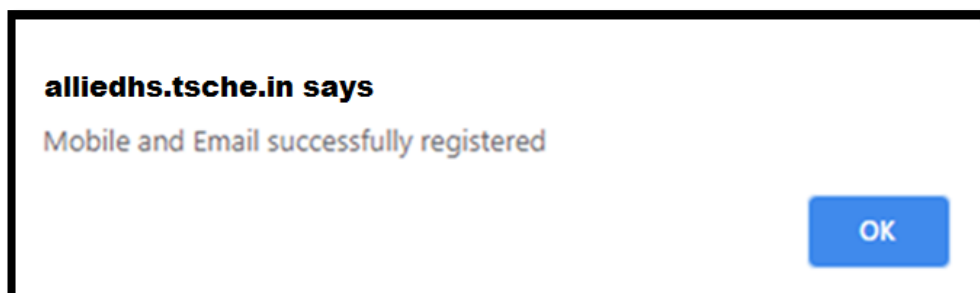



## **5. MERIT LIST:**

**THE PROVISIONAL FINAL MERIT POSITION OF APPLIED CANDIDATES FOR COMPETENT AUTHORITY QUOTA SEATS SHALL BE NOTIFIED AFTER VERIFICATION OF UPLOADED CERTIFICATES.**

The provisional final merit list shall be prepared by the Admission Committee appointed by University subject to these regulations.

### **The Criteria for preparation of Merit list:**

- a. The total percentage of marks obtained in Botany, Zoology, Physics and Chemistry (or optional subjects) in the qualifying examination up to 2 decimal places.
- b. The candidates who qualify under compartmental system will be placed in the Merit List after the candidates who passed in a single attempt.
- c. In case of equality of marks, age shall be taken into consideration and the older candidates shall be given higher place in the merit list.
- d. In case of equality marks and age, the aggregate percentage of marks in all subjects of qualifying examination upto 2 decimal places shall be considered.
- e. Science marks in the Intermediate or its equivalent examination will only be taken into account even in case of the candidates possessing higher qualification.

## **6. PROCEDURE OF SELECTION:**

Selection will be made by the Admission Committee appointed by Vice-Chancellor, KNR University of Health Sciences based on the web-options given by the candidates and their merit.

- a. Selections shall be made local area wise as per the procedure prescribed in Annexure-III of G.O.P.No.646, Education (W) Dept. dated 10-7-1979, as amended in G.O.Ms.No.42, Higher Education (EC2) Dept., dated: 18-05-2009 subsequent amendments and Government orders on Rules for admissions into Allied Health Sciences courses.
- b. The Admission Committee will allot seats to candidates in Courses and Colleges based on their priority of web-options and merit.
- c. Selected candidates will receive the allotment message on the registered mobile number after allotment of a seat. Candidates are directed to login and check their allotment on website after each phase of counseling without fail.

- d. Selected candidates have to download the allotment order on payment of University fee of Rs. 6,000/- (Rupees Six thousand only) besides payment gateway charges through payment gateway. Candidates have to report to the Principal of concerned college along with all Original Certificates and pay the tuition fee and college fee at the college to complete the admission process.

## 7. **ADMISSION RULES**

- a. The Provisional allotment letter for admission of selected candidate shall be downloaded from website after payment of University fee by payment gateway.
  - b. The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee constituted at each college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
  - c. Selected candidates have to join the college within the specified date by submitting all Original Certificates, and pay the tuition fee as notified by the Government and college fee to complete the process of admission. If the candidate does not report within the specified time and complete the process as described before the admission will be automatically cancelled and candidates will not be eligible for further phases of counseling.
8. **COMMENCEMENT OF THE COURSE:** The course shall commence as per the schedule notified. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.
9. **College Regulations:** Candidates are required to follow the rules and regulations

of the college and should also abide by the Regulations of the University. Candidates are informed that their correspondence with the University shall be forwarded by the Principal of college with his remarks (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal

10. The admissions shall be closed as per the schedule notified by the University.

11. Any vacancy after the date of closure of admissions shall not be filled. They will not be carried forward to the next year as per the directions of Hon'ble Supreme Court of India.

12. **POWERS OF THE PRINCIPAL OF THE INSTITUTION**

Notwithstanding anything contained in these Regulations, the Head of the Institution may at any time, either su-moto or on an application made by any person after due and proper enquiry, if satisfied that the candidate has furnished incorrect information or enclosed false certificates or fraudulently obtained admission may for the reasons to be recorded in writing, by order cancel her admission provided that no such admission shall be cancelled without giving a reasonable opportunity for showing cause as to why his/her admission should not be cancelled. Against any such order of the Head of the Institution, an appeal can be made to the Registrar, KNR University Health Sciences.

13. **POWERS OF KNR UNIVERSITY OF HEALTH SCIENCES:**

The University may either suo-moto or on an application made to University can call for and examine the records relating to any selection or admission or cancellation thereof made by the concerned authority for the purpose of verifying the correctness, legality or propriety of such selection or admission or cancellation and pass such order in relation there to as KNRUHS deems fit, including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation.

14. **UNIVERSITY IS THE FINAL AUTHORITY OF SELECTION PROCEDURE:**

All selections made under these regulations shall be subject to such directions or orders as may be made by the University from time to time.

15. **SANCTION OF LEAVE BEYOND (3) MONTHS AND TERMINATION OF STUDENTSHIP:**

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the university.
  - a. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
  - b. The candidate has to pass within the final examination for award of Degree for the course double the duration of study period for the course or within the maximum period permitted by the Indian Nursing Council from time to time.
  - e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".

16. **TIME FOR COMPLETION OF COURSE:** Candidate should complete the course within the duration equivalent to double the period of course of study. i.e.,: 6 Years for BSc (Allied Health Sciences) failing which the admission will be cancelled.

17. **MIGRATION /TRANSFER:**

No Transfers are permitted from one college to another college or from one course to other course under any circumstances.

18. **Discipline:**

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the

Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities /Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.
